

Rules & Regulations

Simply Italian Miami 2009 – Win a trip to Italy

1. Eligibility: The *Simply Italian – Win a Trip to Italy Contest* (from now on the “Contest”) is provided by International Event & Exhibition Management (from now on “IEEM”) to US residents 21 years of age and older. Proof of age and identity must be furnished upon request. Only mail entries will be acceptable. Multiple entries by eligible entrants are allowed. All entries with 2 (two) stamps from the restaurants will be automatically entered for the Grand Prize selection. Incomplete entries will be disqualified. All entries shall become the property of IEEM. IEEM is not responsible for lost, misdirected or delayed entries.
